Second. In the event of my said Husband not surviving me I give devise and bequeath all my estate and property unto my children in equal proportions, share and share alike absolutely and should my said Husband not survive me I appoint my Son-In-Law Elias S. A. de Lima and my son Elias A. de Lima Executors of this my last Will and Guardian of my Infant Children with full power of sale and Disposal as they may see fit; And I exonerate and relieve them from giving bond or Security.

Third. All former Wills by me made are hereby revoked and annulled.
